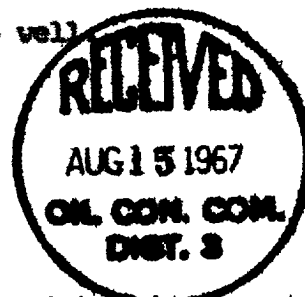

Instructions

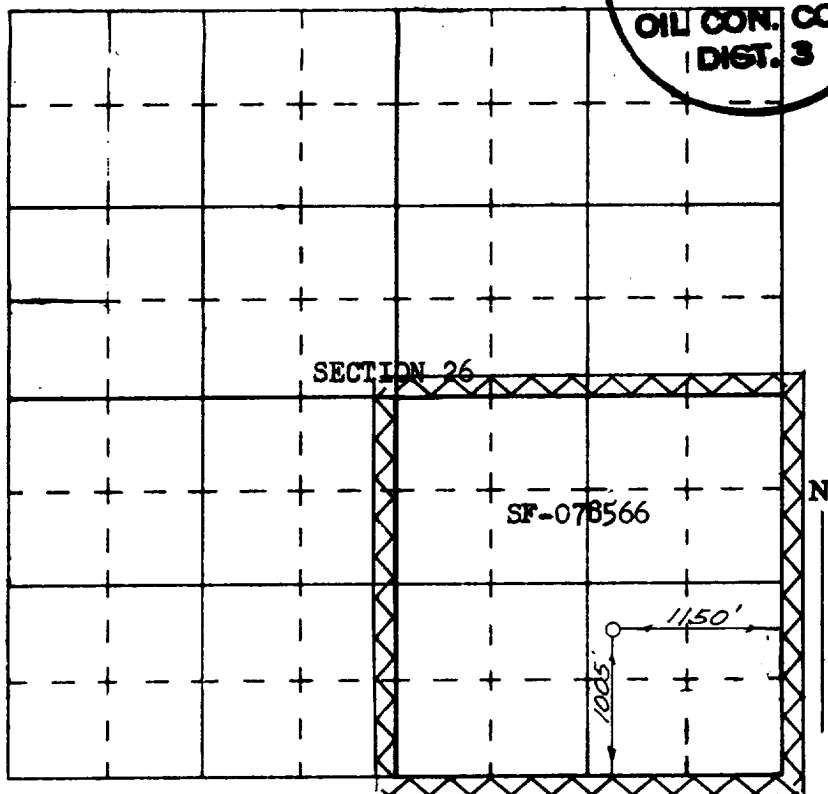
