CASING REPAIR PROCEDURE

1. MIRUSU. Blow well down. Kill if necessary w/ 2% KCl. NDWH. NUBOP.
2. TIH w/ 2-7/8" RBP and pkr. Set RBP at 2400'. Pull one stand, set pkr and PT RBP to 500#. POOH w/ pkr. Spot sand on RBP. Isolate leak using pkr.
3. Establish pump rates and pressures. Determine if there is communication between casing and bradenhead. *(Communication would cause us to change amounts and type of cement)
4. Perform cement squeeze. (amount of cement needed is dependent on findings in steps 2 and 3 above)
5. Displace to just above leak and shut in overnight.
6. WOC 24 hrs. TIH and tag cement. Drill out cement. POOH.
7. PT csg to 500#. TIH. Circulate sand off RBP. Retrieve RBP. POOH.
8. NDBOP. NUWH. RDMOSU.
9. Swab and allow well to blow to pit as required to clear fluid from well.
10. Return well to production.
