On 4-5-69 ran 4 joints 8 5/8", 2 1/2", J-55 surface casing (134') set at ground level w/95 sacks of cement circulated to surface. W.O.C. 12 hours, held 600#/30 Min.

On 4-10-69 T.D. 2372', ran 76 joints 2 7/8", 6 1/2", J-55 casing (2361') set at 2372' w/170 sacks of cement. W.O.C. until completion.

On 4-15-69 P.B.T.D. 2362', tested casing to 4000# O. K. Perf. Pictured Cliffs 2252-56', 2264-68', 2278-90' w/16 SPZ. Frac w/35,000# 10/20 sand, 36,800 gal. water. Max. pr. 4000#, BDP 3000#, avg. tr. pr. 2700#, I.R. 23 BPM. Dropped 2 sets of 16 balls, flushed w/1000 gal. water. ISIP 650#, 5 Min. 600#, 15 Min. 450#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
