On 4-11-69 T.D. 2297', ran 78 joints 2 7/8", 6.4#, J-55 casing (2286') set at 2297' w/160 sacks of cement. W.O.C. until completion.

On 4-18-69 P.B.T.D. 2287', tested casing to 4000# O. K. Perf. Pictured Cliffs 2170-74', 2190-94', 2204-14' w/16 SPZ. Frac w/35,000# 10/20 sand, 35,154 gal. water. Max. pr. 4000#, BDP 2200#, avg. tr. pr. 2800#. I.R. 22 BPM. Dropped 2 sets of 16 balls, flushed w/630 gal. water. ISIP 1000#, 5 Min. 950#, 15 Min. 900#.
