4. Pumped 90 sx Class "B" cement plug fr/3,836' - 1,742'. WOC 2 hrs.
5. RIH & tagged cement @ 1,420'. Perf'd 3 sqz holes @ 880'.
6. Pumped 38 sx Class "B" cement plug fr/880' - 795'. WOC 2 hrs.
7. RIH & tagged cement @ 790'. Perf'd 3 sqz holes @ 193'.
8. Pumped 85 sx Class "B" cement. Circ cement to surf through bradenhead valve.
9. RDMO PU, cement crew & WL trk.
10. Installed DH marker & reclaimed location.
