On November 9, 1972, the above well was perforated 1804-16, 1832-39, 1845-52 with 1 SPF. Spotted 500 gallons 15% HCl and displaced. Breakdown pressure 2500 psi. Sand-water fraced with 35,000 gallons treated water (1X KCl and 10 lbs. Gel per 1,000 gallons) and 5,000 lbs. 20-40, 20,000 lbs. 10-20 and 10,000 lbs. 8-12 sand. Breakdown pressure 2500 psi, maximum treating pressure 2200 psi, minimum 1400 psi and average 1800 psi. AIR 43.5 BPM.
