The 4-1/2" casing was set at 1923' with 425 sacks Class "C" cement with 50-50 Pozmix, 6% Gel and 2 pounds Tuf Plug per sack followed by 75 sacks Class "C" Neat. The cement circulated. The casing was tested with 2,000 pounds OK.

Instructions
