4-5-73

PBTD 2253'. Tested production casing, held 4000#. Perf'd 2144-72' and 2182-2206' with 30 shots per zone. Frac'd with 32,000# 10/20 sand and 36,500 gallons treated water. Dropped one set of 30 balls. Balled off. Flushed with 600 gallons.
