Verbal permission granted to temporarily abandon well (pressure test for casing integrity) in order to maintain wellbore for possible future utilization.

We have completed the pressure test on the subject well as follows:  
MIRU slickline unit. RIH & set plug at 2800'. Loaded well with 2% KCL. Pressure tested casing to 550 psi. Pressure test held OK. Pull plug & RDMO slickline unit. Pressure Chart submitted to NMOCD.
