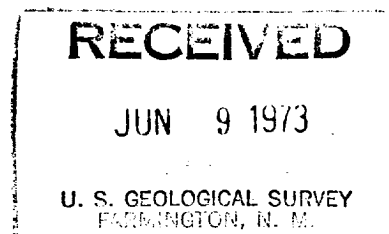

4-27-73 TD 2925'. Ran 96 joints 2 7/8", 6.4#, J-55 production casing, 2914' set at 2925'. Baffle set at 2915'. Cemented with 325 cu. ft. cement. WOC 18 hours. Top of cement at 2000'.

6-5-73 PBTD 2915'. Tested casing to 4000#-OK. Perf'd 2800-15', and 2850-65' with 30 shots per zone. Frac'd with 30,000# 10/20 sand and 30,500 gallons treated water. Dropped one set of 30 balls. Flushed with 720 gallons water.
