10-10-96 MIRU. ND WH. NU BOP. TOO H w/160 jts 2 3/8" tbgs. TIH w/4 1/2" RBP, set @ 3701'. Load hole & circ w/wtr. PT csg to 1000 psi, OK. SDON.

10-11-96 Dump sd on RBP. Displace w/12 bbl wtr. TOO H w/retrieving tool. TIH, ran CBL @ 0-1710', TOC @ 1360' w/stringers to 680'. Perf 2 sqz holes @ 570'. Establish circ. Pump 170 sx Class "B" 65/35 poz w/3% gel. Circ 1 bbl cmt to surface. Close bradenhead valve. Pump 150 sx Class "B" cmt w/2% calcium chloride. Displace w/19 bbl wtr. Sqz to 900 psi. WOC. SDON.
