January 4, 1993

MIRU JC Well Service on 1/4/93. Pulled 42 joints (1330') of 1" tubing, hauled to yard. Establish rate 2 BPM at 50 psi. Mix and pump 37 sacks neat cement (yield 1.15 cu.ft./sack, density 15.6#/gal). Last 15 sack psi increased to 800 psi. Mix and pump 4 sack into annulus, locked up 1000 psi. Rel JC Well Service on 1/4/93. WO dry hole marker and surface rehabilitation.
