PLUGGING PROCEDURES
FEDERAL E 5

- 1) Set CIBP @ 3031' and spot 50' of cement on top of plug
 - 2) Perf @ 1998', place cement plug from 1998' to 1898' inside and outside the casing with 100% excess cement in the annulus and an additional 50 linear feet inside the casing.
 - 3) Perf @ 1551', place cement plug from 1551' to 1349' inside and outside with 100% excess in the annulus and an additional 50 linear feet inside the casing.
 - 4) Perf @ 657', place cement plug from 657' to 557' inside and outside casing with 100% excess in the annulus with and 50 linear feet inside the casing.
 - 5) Perf @ 235' and circulate cement to surface.
