9-4-95 Set RBP @ 6279'. Set pkr @ 6217'. PT RBP to 1000 psi/15 min, OK. Load hole w/100 bbl wtr. PT csg to 1000 psi, failed. Could not establish injection. Isolate hole in csg @ 1040'. TOOH w/pkr. RU, perf 3 sqz holes @ 1055'. RD. TIH w/pkr, set @ 756'. Circ hole w/50 bbl wtr. Pump 10 bbl wtr, 20 bbl gel, 10 bbl wtr ahead. Pump 500 sx Class "G" cmt w/2% calcium chloride. Circ 2 bbl cmt to surface. WOC. SDON.
