1. Set new 10-3/4" 40.5# K-55 ST&C casing at 200'. Pressure test to 1,000#, cement with enough cement to circulate it to surface. Wait on cement 24 hours.
2. Drill with native mud to approximately 1800'. Mud up with Gel-Benex type mud and drill thru the Pictured Cliffs formation (2252-2900') Set 7" 23# K-55 ST&C casing at 2900'. Cement with enough cement to cover the Ojo Alamo and Pictured Cliff formations. Wait on cement 12 hours. Pressure test 7" casing to 3,000 PSI before drilling out.
4. A double pipe and blind ram B.O.P. will be used. B.O.P. will be checked each tower and blinds ran each trip.
5. Drill 6-1/4" hole with gas to total depth. Set and cement 4-1/2" K-55 10.5# new casing from total depth to surface. Enough cement will be used to cover the Dakota and Mesa Verde formations.
6. Wellhead equipment will consist of 3,000# working pressure.
7. Anticipated bottom hole pressure at total depth maximum 2500#, no abnormal pressure anticipated. *gas not checked*

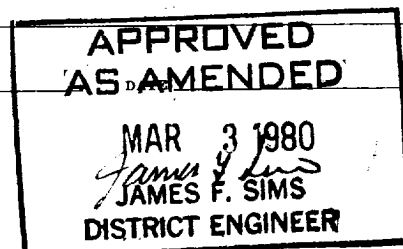

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either the Federal or State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 2: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 3: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.

Items 15 and 18: If well is to be, or has been directionally drilled, give distances for subsurface location of hole in any present or objective production zone.

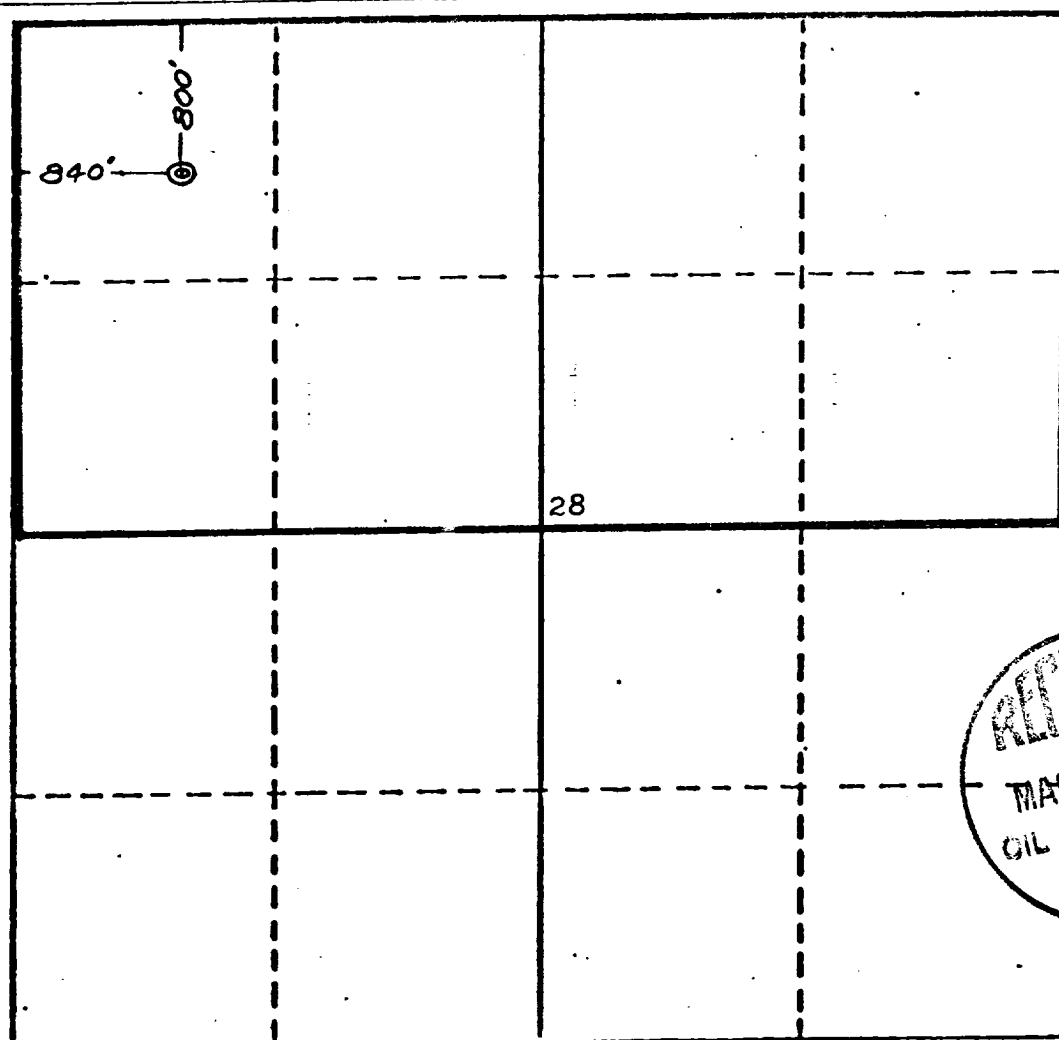
