Perforated intervals from 6828-6792, 6749-6744, 6716-6704, with 2 spf, a total of 106, .38" holes. Sand water fraced with 104,000 gallons of frac fluid and 346,000# of 20-40 sand. Landed 2 3/8" tubing at 6811'. The rig was released on 4-9-81.
