5-10-83 Ran 63 jts. 2-7/8" 6.4#, 8R, NUE new tubing for casing. T.E. 1394.0' set at 1394' GL. Moved in, rigged up Cementers Inc. Ran 10 bbls. of water ahead of 75 sx lodense cement with 1/4# cello flake per sk followed by 50 sx class "B" neat with 1/4# cello flake per sk. Displaced using 8-1/3 bbls. of water. (Total slurry 245 cf) Plug bumped with 1800 psi at 2:45 p.m. 5-9-83. Cementing head shut in with 800 psi. Circulation good throughout job, water ahead of cement circulated to surface; also, 1 bbl. cement circulated to surface. Max pumping rate 6 BPM while pumping water ahead of cement. Max circulating pressure 800 psi prior to bumping plug. Rigging down; will move rig 5-10-83. Reached TD of 1400' on 5-9-83
