Suggested Procedure:

1. Set CIBP @ 6,100' to isolate lower zone.
2. Spot cement plug 50' above (note: plug back depth will be 6,050')
3. Pressure test casing to 500#.
4. Run CBL, CCL & GR over 1450 - 1650. If cement is not behind pipe, squeeze to surface.
5. Perf PC from logs.
6. Fracture stimulate PC formation according to depth and height of formation.
7. Land production string for PC.
8. Temporarily test PC for 60 - 90 days.
9. TOH with production string.
10. Set CIPB above PC; Dump sand
11. Perf FT from logs run previously
12. Fracture stimulate FT formation according to depth and height of formation
13. CO sand, Drill out CIBP
14. CO to PBTD.
15. TIH 2 3/8" production String.
