INSTRUCTIONS

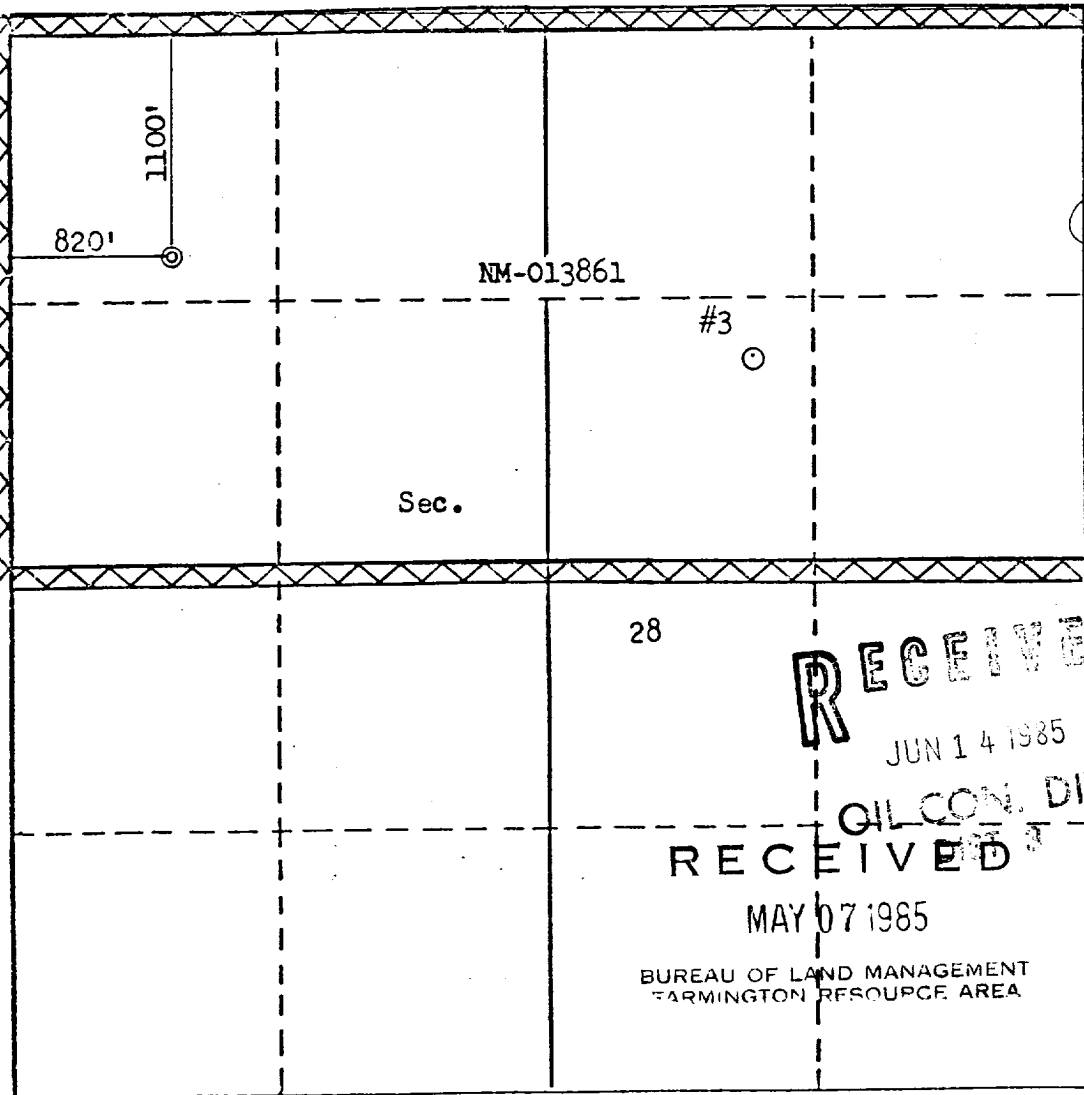

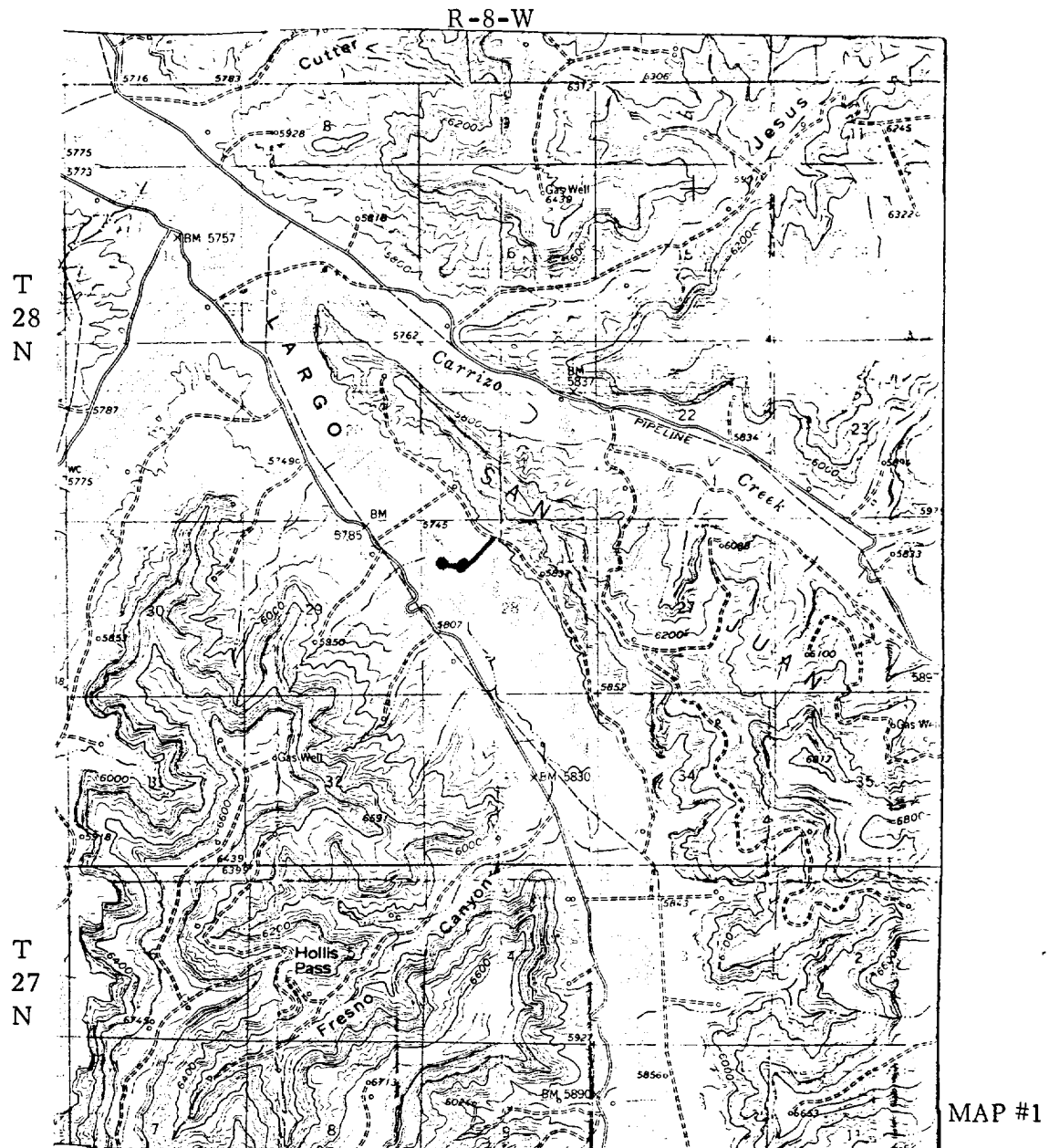
