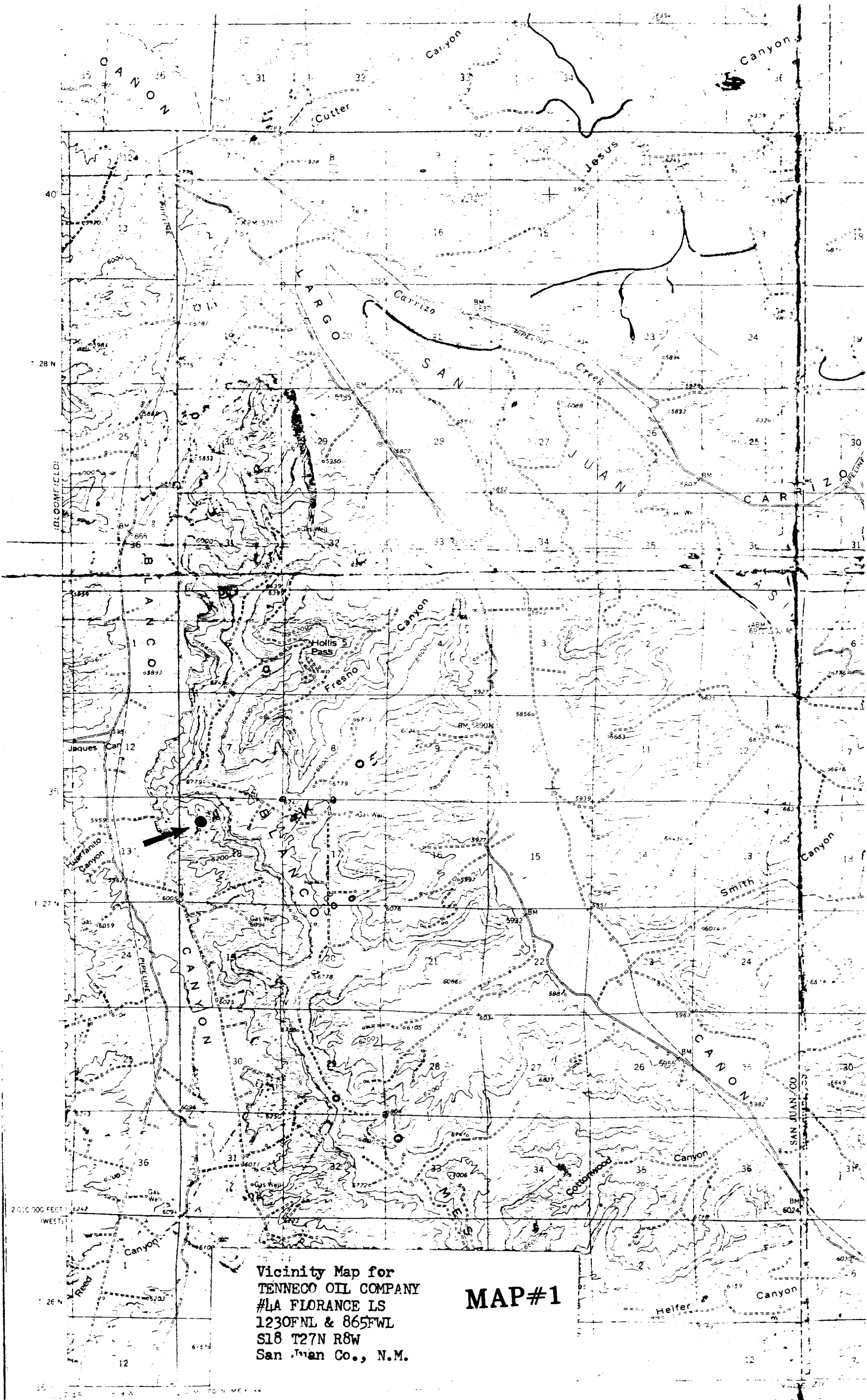




Vicinity Map for

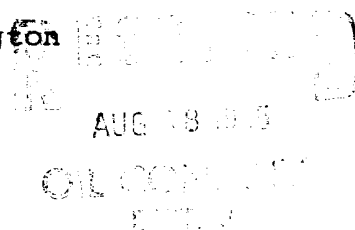
By authority granted me under the provisions of Rule 104 F(I), the above-described unorthodox location is hereby approved.

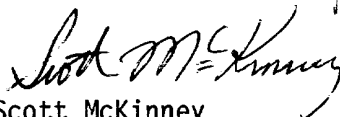
Attached in duplicate (to each office) are a well location plat (C-102) with an ownership plat for the above referenced well.

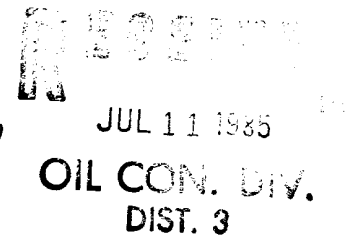
Due to steep topography and cliffs to the north, this location does not meet state spacing requirements. This is the only geologic and topographic site acceptable.
