Class "B" with 1/4#/sk. gel-flake and 3% calcium chloride (177 cu.ft.) followed by 50 sks. Class "B" w/3% calcium chloride (59 cu.ft.) circulated to surface. WOC 12 hrs. Tested 600#/30 minutes, held ok.

04-19-89 TD 1729'. Ran 42 jts. 7", 20.0#, K-55 intermediate casing, 1716' set @ 1729'. Cemented with 220 sks. Class "B" 65/35 with 6% gel, 2% calcium chloride, 1/2 cu.ft. perlite/sx (424 cu.ft.) followed by 100 sks. Class "B" with 2% calcium chloride (118 cu.ft.) circulated to surface. WOC 12 hours. Held 1200#/30 min.
