12-17-93 TIH, tag fill @ 1840'. Load backside w/KCL wtr. Work stuck pkr, backed off tbq. TOOH w/frac string, lost 3 jts. TIH, screw back into tbq. Reverse circ & work stuck pkr.

12-18-93 Ran chem cutter. Stuck @ 1989'. Backed off tbq @ 1940', one jt above pkr. TIH w/spear, jar on fish. TOOH w/fish.
