- 5) RIH w/bit & csg scraper. Circ hole clean & POOH.
- 6) RU loggers. Ran GR-CCL-CBL. Bond across zone of interest.
- 7) RU full lubricator. Perfed Fruitland Coal 1453'-55', 1474'-75' & 1616'-22' w/1 JSPF on July 12, 1990.
- 8) RIH w/fullbore packer on 2-3/8" tubing.
- 9) Acidize formation w/1000 gals 15% HCl and 25 ball sealers at 2.0BPM @2400 psi.
- 10) Release packer & knock off balls.
- 11) Pull up & set packer above perfs.
- 12) Swab well in. Slight blow only.
- 13) POOH w/2-3/8" tbg.
- 14) RU Western. Frac formation w/66,700# sand and 50,400 gals of 70 Quality nitrogen foam @ 15 BPM & 1600 psi down casing.
- 15) Flow well to frac tank.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
