Replace PC Pump with Rod Pump Procedure

- 1. Inspect location. Test safety anchors and replace as needed.
- 2. MIRU PU. Disconnect surface equipment. Hang off pumping unit. .
- 3. Unseat pump. POOH with 7/8" rod string and PC pump.
- 4. ND wellhead and install manual BOP equipment.
- 5. Release tubing anchor. RIH and tag fill. TOOH, laying down PC pump.
- 6. RIH with conventional sand pump on sand line. Clean fill out to PBTD at 1970'.
- 7. TIH with mud joint (open ended), perf sub, API SN and 2 3/8" tubing to surface. Land mud joint at 1950' and SN at 1932'.
- 8. ND BOP equipment. NU wellhead.
- 9. RIH with 1.25" insert pump on steel rod string. Space out pump and hang well on.
- 10. Test pump action. RDMO PU.
- 11. Connect surface equipment and start well pumping to production facilities.
