- 4) RIH w/bit & scraper on 2 3/8" tbg, circ hole clean & press test csg to 2500 psig & POOH.
- 5) RU Loggers ran GR-CCL-CBL. Bond across zone of interest.
- 6) Perf'd Fruitland 1951'-57', 1988'-94' w/2 JSPF on October 14, 1990.
- 7) RIH w/FB packer on 2 3/8" tbg.
- 8) Acidize formation w/1500 gals of 15% NEFE & 40 ball sealers @ 4 1/2 BPM @ 1850 psig
- 9) Release packer & knock off balls. POOH.
- 10) Frac'd formation w/75,500# sand x 50,000 gals of 70 quality nitrogen foam @ 25 BPM @ 1124 psig.
- 11) Flow well to frac tank.
