- 3) Drill out DV tool @ 1108' & FC 2014', PBD 2014' KB.
- 4) RIH w/bit & scraper on 2 3/8" tbg. Circ hole clean & press test csg to 2500 psig & POOH.
- 5) RU Loggers. Ran GR-CCL-CBL. Bond across zone of interest.
- 6) RU full lubricator. Perf'd Fruitland 1941'-51', 1967'-1976', w/2 JSPF on October 14, 1990.
- 7) RIH w/FB packer on 2 3/8" tbg.
- 8) Acidize formation w/1500 gals of 15% NEFE & 60 ball sealers @ 5 BPM @ 1500 psig.
- 9) Released pkr & knock off balls & POOH.
- 10) Frac'd formation w/80,000# sand x 50,000 gals of 70 quality nitrogen foam @ 18 BPM @ 1150 psig.
