This well was completed 1/14/91. Cement jobs on both casing strings circulated cement to surface. Bayless acquired the well 4/1/98. Bayless and partners are drilling and completing new wells on this acquisition now. Analysis of these wells will aid Bayless in the evaluation of the subject well. Bayless requires more time for this evaluation.
