B. Pressure test 5-1/2" OD casing to 3500 psi.
C. Perforate Fruitland Coal zone 1759 to 1771' with 4 SPF.
D. Stimulate Fruitland Coal zone with \pm 25,600 gals. 70 quality N₂ foamed 20# gel, 5000 # 40/70 sand, 42,000# 20/40 sand.
E. Set retrievable bridge plug.
F. Perforate Fruitland Coal zone 1703 to 1705' and 1711 to 1715' with 4 SPF.
G. Stimulate Fruitland Coal zone with \pm 16,300 gals. 70 quality N₂ foamed 20# gel, 5000# 40/70 sand, 21,000# 20/40 sand.
H. Flow well back.
I. Run 1703' 2-3/8" OD, 4.7#, J-55 tubing for production.
J. Produce well.
