The Hancock 13-11 well has never produced. When the well was completed, production was not adequate to justify the expense of acquiring a right-of-way and laying a pipeline across Navajo lands. Louis Dreyfus Natural Gas Corp. acquired the well and proposed a completion in the Pictured Cliffs formation in 1997. This work has not yet been done.

We are again evaluating the economics of a recompleat and pipeline costs. Louis Dreyfus Natural Gas Corp. hereby requests a 60-day extension to the October 25, 1999 response date cited in your letter of September 1, 1999.
