- A. Run Gamma Ray Neutron, CBL electric log via 5-1/2" production casing.
B. Pressure test 5-1/2" OD casing to 3500 psi.
C. Perforate Fruitland Coal zone 1443'-1455' with 4 SPF.
D. Stimulate Fruitland Coal zone with \pm 25,600 gal. 70 quality N₂ foamed 20 lb. gel, 5000 lb. 40/70 sand, 42,000 lb. 20/40 sand.
E. Set retrievable bridge plug.
F. Perforate Fruitland Coal zone 1402 to 1406' and 1383 to 1386' with 4 SPF.
G. Stimulate Fruitland Coal zone with \pm 18,000 gals. 70 quality N₂ foamed 20# gel, 5000# 40/70 sand, 24,500# 20/40 sand.
H. Flow well back.
I. Run \pm 1383' 2-3/8" OD, 4.7#, J-55 tubing for production.
J. Produce well.
