**Update on Bringing Wells on Production**

1) **Hancock 11-13, 1851 FSL & 1088 FWL sec. 11, T. 27 N., R. 12 W., Lease NMSF-079116**

The Navaho's approved the pipeline plan to allow Louis Dreyfus Natural Gas (LDNGC) to return the Hancock 11-13 to production. However, the BIA changed its form in January and requested that LDNGC revise part of its application on 5/1/2001 to get authority for road-bores. Please see the attached fax from Brian Wood with Permits West. LDNGC is preparing to submit the AFE for the pipeline and recompletion to the Picture Cliffs to partners and begin work on the pipeline. The well should be restored to production by September 1, 2001.

2) **Campbell Federal 25-14, sec 25, T. 27N, R. 12W**

The Navaho's approved the pipeline plan to allow Louis Dreyfus Natural Gas (LDNGC) to return the Campbell to production. However, the BIA changed its form in January and requested that LDNGC revise part of its application on 5/1/2001 to get authority for road-bores. The well should be restored to production by September 1, 2001.
