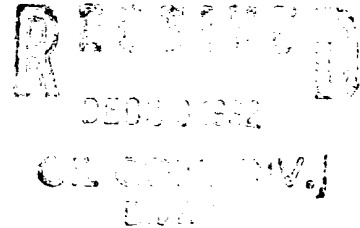

Administrative Order NSL-3209(NSP)

Dear Mr. Garrett:

Reference is made to your application dated November 19, 1992 for a non-standard coal gas well location for your Federal Com "7" Well No. 1 to be located 345 feet from the South line and 1025 feet from the West line (Unit M) of Irregular Section 7, Township 28 North, Range 8 West, NMPM, Basin Fruitland Coal Gas Pool, San Juan County, New Mexico. All of said Section 7 shall be dedicated to the well forming a non-standard 298.76-acre gas spacing and proration unit for said pool.

By the authority granted me under the provisions of Rules 6 and 8 of the Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool as promulgated by Division Order No. R-8768, as amended, the above-described unorthodox coal gas well location and non-standard gas proration unit are hereby approved.

Incline Reserves, Inc. requests approval for a non-standard location for its Fed Com 7 No. 1 well at the location referenced above. In addition, this well will be dedicated to a non-standard unit consisting of all of Section 7, T28N-R9W. This is necessitated by the variation in legal subdivision of the U.S. Public Land Survey. The unit consists of an entire governmental section not less than 70% or more than 130% of a standard gas proration unit. A copy of form C-102 is attached showing this unit to consist of 299.22 acres. Under Rule 5 of Order R-8768-A this non-standard unit may be approved by the Supervisor of the Aztec District Office of the Division.

The circumstance which requires an unorthodox location is the presence of the Largo Canyon wash which transects this section from the northwest to the southeast, as shown on the attached topographic map. The well should be located in the SW/4 of this section to conform with the standard NE/SW pattern in the Fruitland Coal Pool. Local topography and the unconsolidated sands of the Largo Canyon wash dictate that the location chosen is the optimal solution to retaining the integrity of the pattern. Please note that a precedent has been set by the Amoco Warren LS 8, located approximately 400' to the northwest. The location was inspected by Mr. Ernie Bush of the Aztec District III office on November 16, 1992, at which time a verbal approval of the necessity for a non-standard location was given.

The offset mineral interests to the south are owned by Meridian Oil. Mr. John Zent of Meridian was verbally notified of this situation on November 11, 1992, and will receive a copy of this application by certified mail. If no objection is received within 20 days, Incline Reserves respectfully requests administrative approval for this non-standard location.

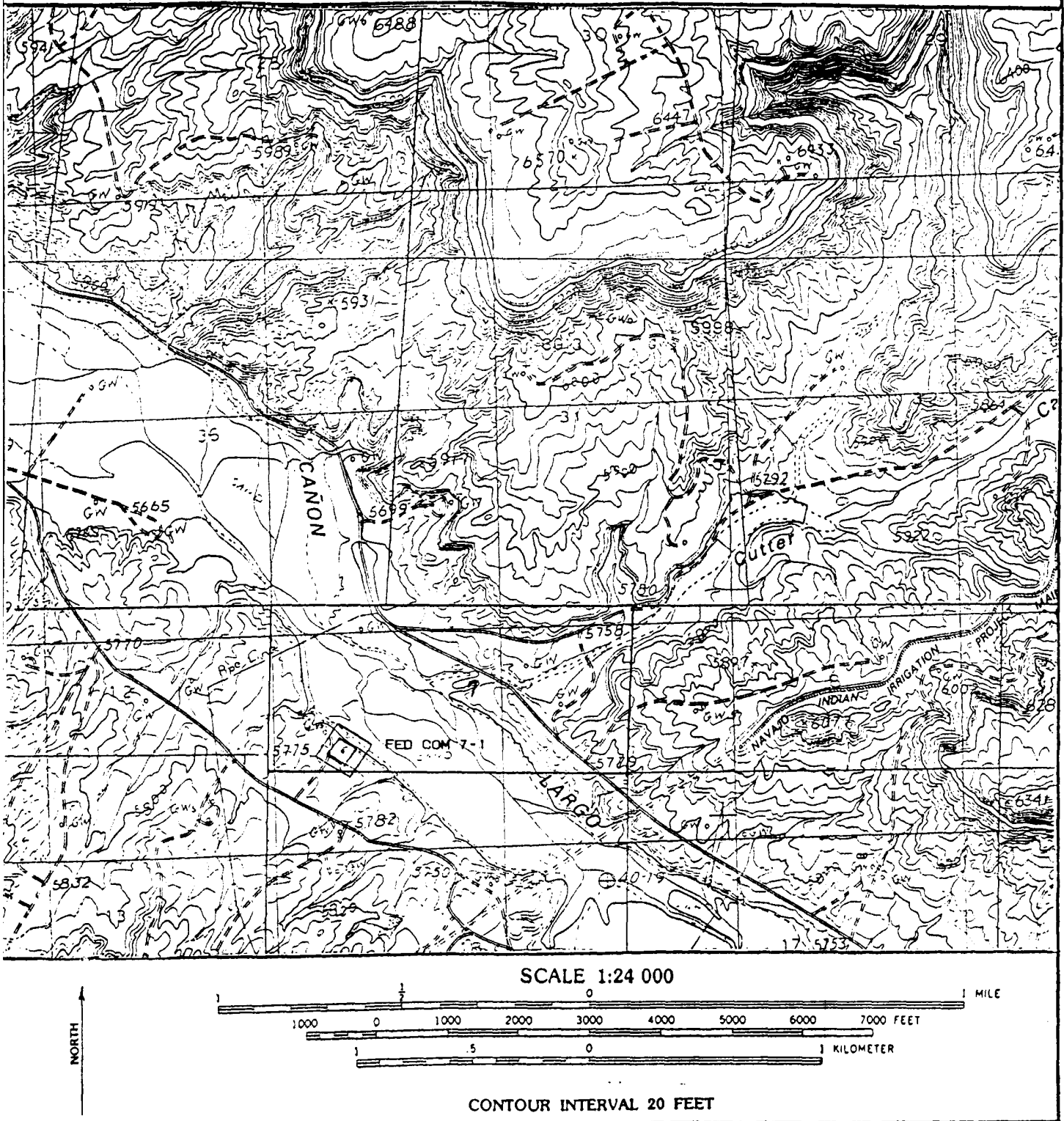


Figure 2. Location map for Incline Reserves Inc. Fed. Com 7-1 well pad.
