Perfed 5 1/2" Csg. @ 1887-90, 1896-1906, 1925-28 with 4/JSPF. With Pkr @ 1873' stimulated 1887-1928 with 1200 gallons 7 1/2% HCL. Fractured 1887-1928 with 55,000 gallons 70 quality N2 foam carrying 150,000# 16/30 Brady sand. Opened well up to frac tank and blew back. POOH with treating string. Cleaned well out to 1992'. R/H with 2 3/8" mud anchor, 3' perforated sub, seating nipple, on 2 3/8" Tbg. Seating nipple @ 1941'. ND BOP. NU well head. Swabbed and flowed to frac tank to recover load and clean up. After well cleaned up turned into test separator. RDMO PU.
