Set 11-3/4" 42# H-40 surface casing at 401'. Cemented with 185 SX CL B, 88 SX Neat. Circulated 10 BBLS to the surface.

Pressure tested casing to 1500 psi. Drilled a 11" hole to a depth of

2445' on 2/7/94. Set 8-5/8" 24#/32# J-55/K-55 intermediate casing at 2443'. Cemented with 1st Stg-180 SX CL B, 2nd Stg-285 SX CL B, Tail w/ 100 SX CL B. Circulated 35 BBLS to the surface. Pressure tested casing to 1500 psi.

Drilled a 7.875" hole to a TD depth of 6735' on 2/11/94. Set 5.5", 15.5#, K-55 Production

Long string from surf to btm 6735' cemented with 775' SX 50/50 POZ TOC @ 1900'

Rig released at 0700 hrs. on 2/11/94.
