02/16/02: Tagged fill @ 1,985' (21' fill). TOH w/tbg, SN & NC. TIH w/2-3/8" x 30' OPMA (top 4' slotted), SN & 61 jts 2-3/8" tbg. EOT set @ 1,950'. SN set @ 1,920'. TIH w/2x 1-1/2" x 10' RWAC- Z pmp w/3/4" x 10' GAC, RHBO tool, spiral rod guide, 1' x 1" lift sub, 75 3/4" rods, 3 3/4" pony rods (8', 6' & 4') & 1-1/4" x 16' PR w/8' liner. Pressure tested tubing to 500 psig. Held OK for 5". Good PA. RDMO PU.

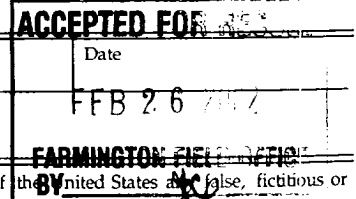
