WELL NAME: Schwerdtfeger 'A LS' Well No.15A  
DESCRIPTION: N/2 of Section 21, and;

WELL NAME: Schwerdtfeger 'A LS' Well No.16A  
DESCRIPTION: NW/4 of Section 21,

both in Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico.

The above-named company is hereby authorized to commingle Blanco Mesaverde (Prorated Gas) and South Blanco Pictured Cliffs (Gas) Pool production in a common facility and to determine production from each pool by separately metering the production from the Schwerdtfeger 'A LS' Well No.15A, Blanco Mesaverde Pool and determining the Schwerdtfeger 'A LS' Well No.16A, South Blanco Pictured Cliffs Pool Production by the subtraction method. (If this method is to be authorized, all commingled production must be of marginal nature; further the operator shall notify the Santa Fe office of the Division in the event any well on the commingled facility becomes capable of the allowable production, at which time the Division will amend this order or take such other action as may be appropriate.)

FURTHER: Validation of this authority shall be accomplished by like approval of the U.S. Bureau of Land Management.

REMARKS: The operator shall notify the Aztec District Office of the Division upon implementation of the commingling process.

NOTE: This installation shall be installed and operated in accordance with the applicable provisions of Rule 303 of the Division Rules and Regulations and the Division "Manual for the Installation and Operation of Commingling Facilities." It is the responsibility of the producer to notify the transporter of this commingling authority.
