Cemented casing w/85/sx Cl "B" cmt w/2% CaCl2 & 1/4#/sx celloflake (15.6 ppg, 1.18 cuft.sx). Circulated 8 bbls cement to surface.

Pressure tested BOP's & surface casing to 800 psig for 30 minutes. Held OK. Resumed drilling ahead.
