Cross Timbers Operating Co. reached Total Depth (TD) of 4,995' KB on the above mentioned well at 8:00 a.m. on 7/4/01.

Open Hole logs (AIL/SP/GR/Cal/CN/Density) were run from a depth of 4,991' (loggers TD) to the btm of the surf casing.

On 7/5/01, 111 jts of 4-1/2", 10.5#, J-55 casing was run and set at a depth of 4,992' KB. The 4-1/2" casing was cemented with 922 (total) sx of cement. 53 bbls of cement was circulated to the surface. ND BOP's. Set slips. Released Bearcat rig #1 @ 8:00 p.m.

NOTE: THE 4-1/2" PRODUCTION CASING WILL BE PRESSURE TESTED AT THE TIME OF COMPLETION AND WILL BE REPORTED AS REQUIRED. THE DRILLING RIG (TYPICALLY) CAN NOT PRESSRE TEST THE PRODUCTION CASING.
