XTO Energy Inc is requesting approval to add a "tail" cement slurry on the production casing for the above mentioned well. Originally XTO had specified a single cement slurry for the production casing cement job. Due to the upcoming completion, engineering has requested a better cement slurry "on bottom". XTO is requesting to use 100 sx of Type III neat with 2% CaCl<sub>2</sub> & 1/4#/sx celloflake (14.5 ppg, 1.41 cuft/sx) in addition to the 65/35/6 slurry as originally proposed.
