Reached drillers TD of 2,293' KB @ 3:30 p.m., 12/13/01. Ran 52 joints 4-1/2", 10.5#. J-55 casing. Set casing @ 2,293' KB. Cemented casing w/155 sx Premium Lite HS (12.5 ppg, 2.00 cuft/sx) followed by 150 sx Type III (14.5 ppg, 1.41 cuft/sx). Circulated 40 bbls cmt to surface. Set slips. Released rig.
