Topped out down 1" tubing with 25 sx CI "B" cmt w/3% CaCl2 & 1/2#/sx celloflake (15.6 ppg, 1.18 cuft/sx. Circ cement to surf via 1" tbg and shut down. Pressure tested BOP & surf csg to 800 psig for 30 min. Held OK.
