2/16/02 NU BOP. PT BOP & csg to 600 psi/30 mins, OK. Drilling ahead.

2/17/02 Drill to TD @ 2523'. Circ hole clean. TOOH. TIH w/78 jts 2-7/8" 6.5# J-55 EUE csg, set @ 2513'. Cmdt w/340 sxs Premium Lite FM w/3% calcium chloride, 0.25 pps celloflake, 5 pps LCM-1, 0.4% fluid loss, 0.4% sodium metasilicate (724 cu. Ft.). Tail w/90 sxs Type III w/1% calcium chloride, 0.2% fluid loss, 0.25 pps celloflake (124 cu. Ft.). Circ 60 bbls cmt to surface. ND BOP. NU WH. RD. Rig released.
