Cemented casing with 250 sx C1 "B" cement w/2% CaCl2 & 1/4#/sx celloflake (15.6 ppg, 1.18 cuft/sx). Circ 11 bbls cement to surface. PT BOP's & surface casing to 1,000 psig for 30 minutes. Held OK.

Reached drillers TD of 4,958' KB @ 2:30 a.m., 4/29/02. TIH w/122 jts 4-1/2", 10.5#, J-55 ST&C casing to 4,956.79' KB. Cemented casing w/125 sx Type III 1/4#/sx cello (mixed @ 11.4 ppg, 2.89 cuft) followed by 150 sx Premium Lite HS w/2% KCl, 4.5% gel & 1/4#/sx cello (12.5 ppg & 2.01 cuft/sx). Circ 50 bbls cement to surface. Cemented second stage w/400 sx Type III, 1/4#/sx cello (11.4 ppg & 2.89 cuft/sx). Circ 45 bbls cement to surface.
