XTO Energy Inc. requests approval to modify the proposed drilling program for the above mentioned well as follows: Install a DV tool @ +/- 4,000'.

Cement the 1st stage w/ +/- 245 sx Premium Lite HS cement w/2% KCl, 1/4# celloflake, 0.2% dispersant, 0.5% fluid loss & 2% Phenoseal (12.5 ppg, 2.01 cuft/sx, 10.55 gps). Attempt to circ cement to DV tool.

Cement 2nd stage w/(lead) 325 sx Lite cement w/3% extender, 1/4# celloflake & 2% Phenoseal (11.4 ppg, 2.94 cuft/sx, 17.96 gps) followed by 160 sx Premium Lite HS cement w/2% KCl, 1/4# celloflake & 2% Phenoseal (12.5 ppg, 2.01 cuft/sx, 10.55 gps). Attempt to circ cement to surface.

NOTE: Actual cement volumes may change based on caliper log volume plus 40% excess.
