Cemented casing w/250 sx Type III cement w/3% extender, 2% gel, 2% Phenoseal (11.4 ppg & 2.94 cuft/sx), followed by 150 sx Type III cement w/1% CaCl₂ (14.5 ppg & 1.40 cuft/sx). Circulated 55 bbls cement to surface. PT BOP's & 7" intermediate casing to 2,000 psig for 30 minutes. Held OK.

Resumed drilling ahead.
