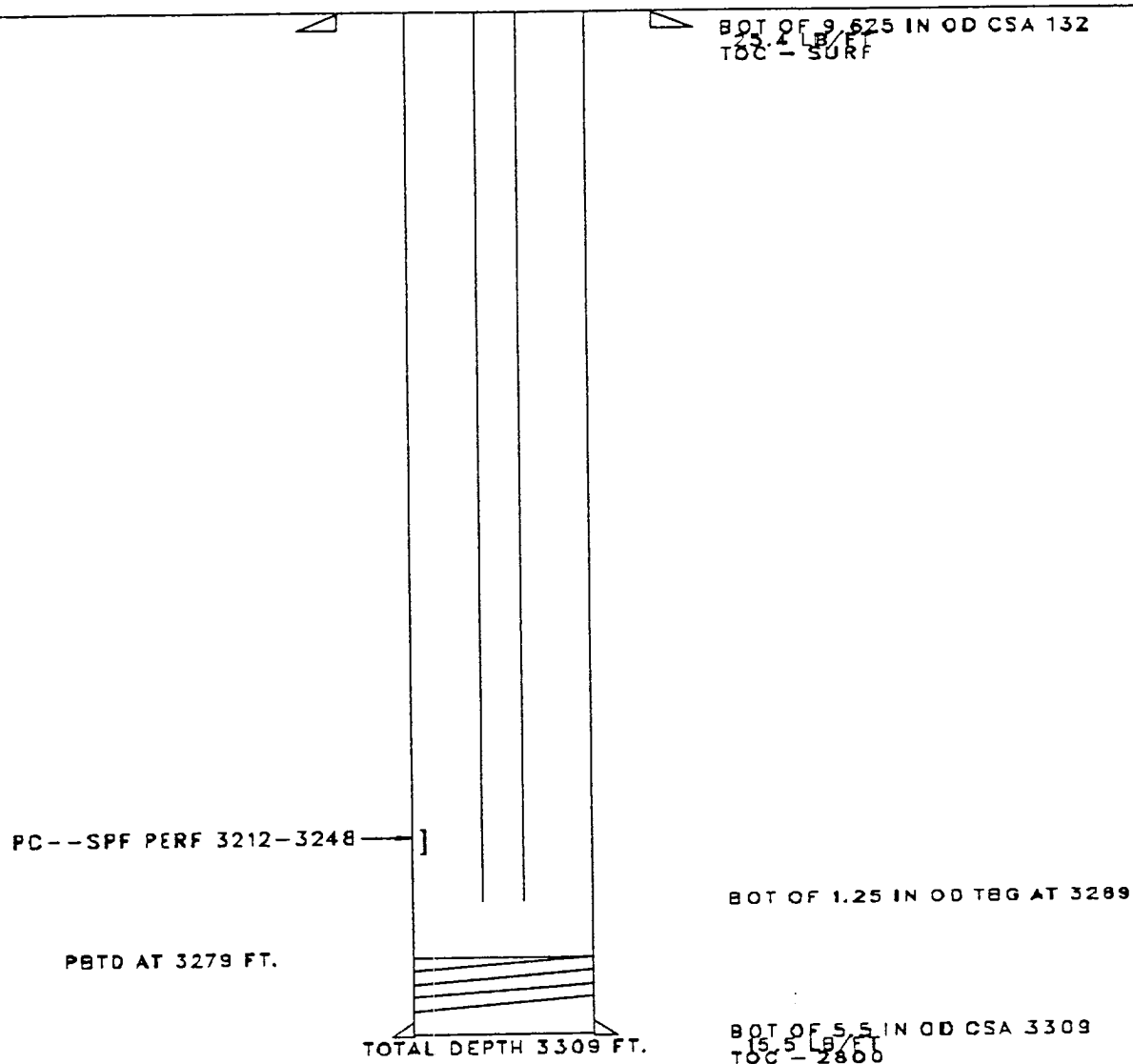

Storey C LS #1
Pictures Cliffs only

1. Check location for anchors. Install if necessary. Test anchors.
2. MIRUSU. Blow down well. Kill if necessary with 2% KCL water. NDWH. NUBOP.
3. POOH with 1 1/4" tbg. RIH with 2 3/8" workstring and retainer. Set retainer at 3162'. Squeeze perfs at 3212' to 3248' with 32.925 cuft cement. Pull out of retainer.
4. Test casing integrity to 500#. Isolate casing leaks and report findings to Carolanne Wyett, 5578 or Mike Kutas, 5159 in Denver for further instructions.
