4/30/86 MIRUSU. NDWH. NUBOP. POOH w/1". Tbg had parted. Left 25-26 jts in the hole. Tbg had parted about 8" above the collar.

5/1/86 Cut off 7" x 2" bell nipple. Installed new wellhead. Tallied, PU and RIH w/2-3/8" tbg, overshot, set dn on the fish. POOH w/same. RIH w/tbg, bit sub and 6-1/4" bit. Cleaned out to PBTB w/foam. POOH w/tbg, bit and bit sub. RIH w/tbg, 7" pkr. Set @ 2100'. Loaded the backside. PT the csg to 2500 psi. Held OK. Blowed dn the well w/nitrogen. POOH w/tbg and pkr, laying down 2-3/8" tbg.

5/2/86-5/3/86 RIH w/GR-CCL. Perforated Pictured Cliffs, 4 JSPF, 4" csg. gun. Perforated from 2124' to 2165', 41' - 164 holes. Frac down csg w/130,000# 20/40 sand & 62,000 gal 70 quality foam w/2% KCL. Well treated @ 26 BPM, @ 1200 psi. ISIP = 1160. Shut well in for 2 hrs. Open up to pit thru 1/2" tap bull plug. Left well flowing

5/4/86 Shut down for Sat and Sunday. FTCU.

5/5/86 Talley, PU, RIH w/1-1/4" tbg. Tagged sand fill @ 2200'. Cleaned out to PBTB w/foam. PU and landed tbg @ 2152'. NDBOP. NUWH. Kicked well around w/nitrogen. Left well flowing. RDMOSU.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
