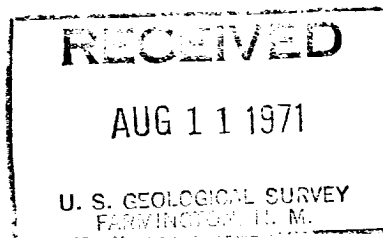

7-13-71 T.D. 2514'. Ran 81 joints 2 7/8", 6.4#, J-55 production casing (2502') set at 2514' w/185 sacks of cement. W.O.C. until completion.

7-26-71 P.B.T.D. 2504'. Perf. 2388-98', 2408-23' w/30 SPZ. Frac w/30,000# 10/20 sand, 27,720 gal. water, dropped 1 set of 30 balls, flushed w/840 gallons of water.

Instructions
