16. Intent to/Subsequent Report of : Repair/Fracture/Multiple Comp/

17. Describe proposed or completed operations:

It is intended to repair communication between zones, abandon the Mesa Verde and recomplete the Chacra in the following manner:

TOOH w/2 3/8" tbg and packer. Set retrievable BP above MV perf's and test. Reset below MV perfs. TIH w/2 3/8" tbg. Squeeze MV perforations w/23 sx (27 cu.ft.) Class "B" cmt w/0.95% FLA. WOC 18 hrs. Drill out cmt and test to 800 psi. Reset RBP @ 3000' and test. Spot 150 gal. 7.5% HCl acid 2806-2938'. Run GR-CCL. Perf Chacra zone w/16 holes. Perform breakdown w/ball sealers and 15% HCl acid. Fracture treat well w/70% quality N2 foam and 20/40 mesh sand. Flow well back and clean out. Retrieve bridge plug at 3000'. Clean well out to PBTD @ 6430'. Complete w/dual strings of 1 1/2", 2.76# J-55 10rd IJ tubing. Run packer on long string below Chacra perforations. Run blast joints across Chacra perforations. Long string to be set at 6350'. Short string to be set @ 2900'. RD and release rig.
