Chacra & Dakota Allocation Method

Potential producing rates (without liquid loading) were determined for each formation by analyzing production decline curves. See enclosed curves for the Otero Chacra and Basin Dakota. Decline rates for both formations were assumed to be the same.

Otero Chacra potential: 0 BOPM
 600 MCFPM

Basin Dakota potential: 30 BOPM
 2000 MCFPM

Gas Allocation: Chacra $\frac{600}{600 + 2000} = .23$ or 23% of total commingled production.

Gas Allocation: Dakota $\frac{2000}{600 + 2000} = .77$ or 77% of total commingled production

All oil production should be allocated to the Dakota.
